## **Swim Lesson Contract & Waiver Form**

Dear Parent/Guardian (the "Parent"),

Please complete this Waiver of Liability form prior to admittance into swim lessons (the "Activity" or "Lessons"). The following is a legal document. It is important that you read and understand the provisions of this document before signing it. Your signature on this document is a binding agreement between you and the Hannibal Parks & Recreation Department/City of Hannibal (individually and collectively, "Parks & Recreation"). Parents are responsible for their child(ren) both before and after their Lessons. Refunds will only be given if cancellation occurs at least 14 days prior to the first lesson.

### **Agreement, Waiver, and Release**

I, the Parent, have carefully read the description of Lessons for which I am registering my child(ren), and, in consideration for being permitted by Parks & Recreation to participate in the activity, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which my child(ren) may have, or which may hereafter inure to my child(ren), as a result of participation in Lessons. I hereby acknowledge that participation in Lessons does not guaranty that my child(ren) will be water-safe. This release is intended to discharge in advance Parks & Recreation from any and all liability arising out of, or connected in any way, with my child(ren)'s participation in the Lessons, except as such matters may arise from the gross negligence on the part of an employee of Parks & Recreation. It is understood that this Activity involves an element of risk and danger of accidents, and knowing those risks, I hereby assume those risks for my child(ren). It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns, or any person claiming through me. I agree to indemnify and to hold Parks & Recreation free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my child(ren)'s death or injury or property damage that they may sustain while participating in the Activity.

### **Parental Consent**

I HAVE CAREFULLY READ THIS AGREEMENT, WAIVER, AND RELEASE AND FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN THE HANNIBAL PARKS & RECREATION DEPARTMENT/CITY OF HANNIBAL AND ME, AND I SIGN IT OF MY OWN FREE WILL.
